## FROM THE ACTING MARITIME ADMINISTRATOR:

Friends and Members of the Kings Point Community, I'd like to update you on a two important announcements concerning the U.S. Merchant Marine Academy.

In May of 2009, Secretary of Transportation Ray LaHood asked the Maritime Administration to assemble an independent "Blue Ribbon Panel" to review the 2008 Capital Improvement Plan prepared by USMMA, and advise the Department on the priority and efficacy of projects that should be undertaken. Five U.S. Government senior executives from outside the Department participated in the Panel. Members were selected for their knowledge of the maritime industry, management and administration of federal academic institutions, and current engineering and construction practices. They graciously accepted this responsibility and their contributions to this project have proven to be invaluable. The Panel met at length with USMMA leadership and senior administrators, toured the campus, and inspected the physical condition of the all the major facilities. Confronted with the situation of an aged facility in need of major infrastructure renovations, and capital improvements and maintenance needs that exceed available funding, the Panel, using cost and construction information validated by an independent engineering firm, reviewed twenty major projects for inclusion in the Academy's capital improvement budget for FY 2011-2020. The Panel also recommends significant changes to the way in which the Academy, and the Agency, manage capital improvement projects.

The Secretary has accepted the Panel's recommendations, and I intend to implement them. As discussed in the Panel's Final Report, the U.S. Merchant Marine Academy continues to be an integral part of our marine economy. Unfortunately, we as nation have failed to provide the funding necessary to maintain the Academy's critical infrastructure. It is a top priority of this Administration, and Secretary LaHood and I intend to work closely with Congress to provide the funding necessary to correct this, and make the Academy the jewel of the Federal academies.
